Pass Holder Terms and Agreement

PAYMENT - The Pass Holder dues must be paid in full to commence use of the program. Payment must be made in person in the Golf Shop or by mail. Please make checks payable to Ely Park.

REFUSAL OF PRIVILEGE - Ely Park shall have the right to refuse golf course privileges to anyone who is judged to be in violation of the established rules and regulations herein.

REGISTRATION - All golfers must register and sign in at the golf shop before play. Pass holders are required to show their pass (which is non-transferable).

HOLIDAYS - Ely Park recognizes the following holidays: Memorial Day, Independence Day, Labor Day, Thanksgiving. Weekend rates apply to these days.

TEE TIME RESERVATIONS - Cancellation Policy - Each Pass Holder has the capability of reserving tee times up to 14 days in advance. Ely Park reserves the right to pair all twosomes and threesomes. When reserving tee times, Pass Holders are responsible for the number of players booked. Ely Park has implemented a 24-hour cancellation policy. Pass Holders are responsible for calling the Golf Shop with any changes to tee times. Pass Holders who short show or no show will be subject to a no show charge for each player. Groups that habitually no-show will be subject to pass holder suspension. No groups are permitted to have more than four players per tee time. Pass Holder rates not valid for pre-booked outings or events.

DRESS CODE - Golfers are expected to wear traditional golf attire on the course. Ely Park is a non-metal spike facility.

PACE OF PLAY - All Pass Holders are expected to abide by the pace of play policies instituted by Ely Park Management. Players are expected to play in 4 hours and 30 minutes or less.

COURTEOUS PLAY - It is golfing etiquette to replace divots, repair ball marks on greens, rake smooth all marks made in sand traps and remove used tees from the teeing grounds. Please assist us in the upkeep of the course and encourage your guests to do likewise.

LIMITATION OF LIABILITY – Ely Park will not be liable for any lost profits or for any indirect, incidental, consequential, punitive or other special damages suffered by the player arising out of or related to this Agreement even if Ely Park has been advised of the possibility of such damages. In no event shall the total cumulative liability of Ely Park in connection with the Agreement from all causes of action of any kind (including tort, contract negligence, strict liability, breach warranty and fundamental breach) exceed the total amount paid by the player to Ely Park under this Agreement.
